HOW TO APPLY — LEGAL SERVICES

Where Can You Get Legal Advice?

The Legal Aid Department does not provide free legal advice service. If you need legal advice, you can consider approaching a solicitor in private sector or get assistance under the following schemes.

Free Legal Advice Scheme

The Free Legal Advice Scheme managed by the Duty Lawyer Service provides free and preliminary legal advice service to the public. The Scheme has nine Legal Advice Centres, each of which is in a District Office.

Legal Advice Scheme for Unrepresented Litigants on Civil Procedures (Procedural Advice Scheme)

The Procedural Advice Scheme provides free legal advice on civil procedural matters for unrepresented litigants. It assists unrepresented litigants who—

- (i) are parties to civil legal proceedings in the Lands Tribunal, the District Court, the Family Court, the Court of First Instance or the Court of Appeal of the High Court, or the Court of Final Appeal (including commencement of proceedings); and
- (ii) have not been granted legal aid and have not engaged lawyers.

The Duty Lawyer Scheme

If you have been charged with a criminal offence in the Magistrates' Courts, you should contact the Court Liaison Office of the Duty Lawyer Service where you appear. Legal representation will be provided to eligible defendants under this Scheme. Defendants held in custody are automatically contacted by the staff of the Court Liaison Office offering the service on the day of their first court appearance. Bar Free Legal Service Scheme

The Hong Kong Bar Association runs the Bar Free Legal Service Scheme to provide free legal advice and representation in cases where legal aid is not available and where the applicant is unable to afford legal assistance. The assistance provided at the Centre is confined to procedural matters only. The staff will not give legal advice or make any comment on the merits of the case. Mediation

The Integrated Mediation Office, which is situated at Room 113, 1/F, Wanchai Tower, 12 Harbour Road, Wanchai, Hong Kong, assists parties/litigants in court proceedings to seek mediation from accredited mediators. The Office answers enquiries and provides information on court-related mediation. However, staff will not give any legal advice or offer any comment or assistance on the conduct of specific court cases and proceedings.
