Examples of Means Tests for Applications under Ordinary Legal Aid Scheme (OLAS) (For reference only)

Example 4 – Over on Means

Assuming the personal allowance for the applicant is \$7,630 and assuming the financial eligibility limit for OLAS is \$449,620

Financial position of applicant	
Monthly income (gross)	\$44,000
Monthly contribution to Mandatory Provident Fund	\$1,500
Monthly rental payment	\$16,000
Salaries tax for previous year	\$46,260
Savings account credit balance	\$200,000
Shareholdings	\$150,000

Means test calculation

Monthly disposable income

- = \$44,000 (gross monthly income) \$1,500 (contribution to MPF) \$7,630 (personal allowance for applicant) \$16,000 (rent) \$3,855 (salaries tax on a monthly basis)
- = \$15,015

Disposable capital

- = \$200,000 (applicant's savings) + \$150,000 (value of shares)
- = \$350,000

Total financial resources = Monthly disposable income x 12 + disposable capital = \$15,015 x 12 + \$350,000 = \$530,180

Assessment

As the applicant's financial resources exceed the financial eligibility limit of OLAS, he fails the means test and is not eligible for legal aid.
